Danny,

Marjie ended up in the hospital on January 15, 2009, for about a week and then has been in recovery at home for the month of February. She is just getting back on her feet, and we are now getting back to the Estate issues. The Court date was postponed.

On 10/16/08, 12/4/08, 12/23/08 and 1/10/09 we requested in writing via email, to receive the records of the work you have done for the Hamilton Estate. You demanded that I pay Sylvia's bills from you before I could have a copy, without ever giving me a bill, or asking me for any tax receipts. I have no idea why you would assume that your tax calculations are correct without letting me look them over before you declare them done.

Wayne sent us an email yesterday saying that you had given Sylvia a copy of the 2004, 2005 and 2006 tax returns, and that she had dropped them off at Wayne's office. Sylvia is not Executor of the Estate, she is the one who you gave \$800,000 to and that now says she doesn't have any money to pay you, and somehow, you have had contact with her and decided to give her the taxes, rather than mail them to me, the Executor of the Estate, who has been asking you for them in writing for 6 months.

Nor have you have replied to this email, nor have we received the 2004 billing records in the mail from you. We also need to know where you got a copy of the 2003 taxes on which the 2004 taxes are based.

Please send a copy of your 2004 billing records and the copy of the 2003 taxes from which you started the 2004 taxes with, immediately. Email would be fastest and is preferred, but you can also use snail mail to: 9902 Childress, Austin, Texas, 78753.

You want me to pay the bills without seeing anything, and yet you appear to be working with and for Sylvia, while sending me the bill. I cannot sign and file tax returns for the Estate. under the penalty of perjury, if I am not given copies of the Estate records that you have so far refused to give me. Attached is a copy of the Letters Testamentary from the Court.
